1. If the bidder is a Micro or Small Enterprise as per latest definitions under MSME rules, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria" subject to meeting of quality and technical specifications. If the bidder is OEM of the offered products, it would be exempted from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. In case any bidder is seeking exemption from Turnover / Experience Criteria, the supporting documents to prove his eligibility for exemption must be uploaded for evaluation by the buyer.

2. If the bidder is a Startup, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria" subject to their meeting of quality and technical specifications. If the bidder is OEM of the offered products, it would be exempted from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. In case any bidder is seeking exemption from Turnover / Experience Criteria, the supporting documents to prove his eligibility for exemption must be uploaded for evaluation by the buyer.

3. The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated above in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the bidder is less than 3-year-old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.

4. Experience Criteria: In respect of the filter applied for experience criteria, the Bidder or its OEM {themselves or through reseller(s)} should have regularly, manufactured and supplied same or similar Category Products to any Central / State Govt Organization / PSU for number of Financial years as indicated above in the bid document before the bid opening date. Copies of relevant contracts to be submitted along with bid in support of having supplied some quantity during each of the Financial year. In case of bunch bids, the category of primary product having highest value should meet this criterion.

5. Preference to Make In India products (For bids < 200 Crore): Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. If the bidder wants to avail the Purchase preference, the bidder must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which no purchase preference shall be granted. In case the bid value is more than Rs 10 Crore, the declaration relating to percentage of local content shall be certified by the statutory auditor or cost auditor, if the OEM is a company and by a practicing cost accountant or a chartered accountant for OEMs other than companies as per the Public Procurement (preference to Make-in -India) order 2017 dated 04.06.2020. Only Class-I and Class-II Local suppliers as per MII order dated 4.6.2020 will be eligible to bid. Non - Local suppliers as per MII order dated 04.06.2020 are not eligible to participate. However, eligible micro and small enterprises will be allowed to participate. The buyers are advised to refer the OM No.F.1/4/2021-PPD dated 18.05.2023.

6. Purchase preference will be given to MSEs having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service and Buyer will decide eligibility for purchase preference based on documentary evidence submitted, while evaluating the bid. If L-1 is not an MSE and MSE Seller (s) has / have quoted price within L-1+ 15% (Selected by Buyer) of margin of purchase preference /price band defined in relevant policy, such MSE Seller shall be given opportunity to match L-1 price and contract will be awarded for 25% (selected by Buyer) percentage of total quantity. The buyers are advised to refer the OM No. F.1/4/2021-PPD dated 18.05.2023 [OM No.1 4 2021 PPD dated 18.05.2023](#) for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be allowed only if seller is validated on-line in GeM profile as well as validated and approved by Buyer after evaluation of documents

submitted.

7. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

8. Past Performance: The Bidder or its OEM {themselves or through re-seller(s)} should have supplied same or similar Category Products for 10% of bid quantity, in at least one of the last three Financial years before the bid opening date to any Central / State Govt Organization / PSU. Copies of relevant contracts (proving supply of cumulative order quantity in any one financial year) to be submitted along with bid in support of quantity supplied in the relevant Financial year. In case of bunch bids, the category related to primary product having highest bid value should meet this criterion.

1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity by up to 25% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.

2. Service & Support

Availability of Service Centres: Bidder/OEM must have a Functional Service Centre in the State of each Consignee's Location in case of carry-in warranty. (Not applicable in case of goods having on-site warranty). If service center is not already there at the time of bidding, successful bidder / OEM shall have to establish one within 30 days of award of contract. Payment shall be released only after submission of documentary evidence of having Functional Service Centre.

3. Certificates

Bidder's offer is liable to be rejected if they don't upload any of the certificates / documents sought in the Bid document, ATC and Corrigendum if any.

4. Buyer Added Bid Specific ATC

Buyer Added text based ATC clauses

1. The bidder shall be an OEM/authorised by OEM of the tendered item. If the bidder is not an OEM, Original authorisation letter from their OEM's letterhead - as per the format given should be submitted/uploaded from the same location of consignee. As per CVC guidelines, the OEM and Reseller should not participate in the tender simultaneously and in the case, both bids will be disqualified. Dealership/ Partnership certificates / system generated document without sign / invalid date or limited validity certificates are not acceptable.
2. The bidder must have Min. 05 years of experience in the business of Computer selling/installation/maintenance. Suitable / complete supportive documents in claim of bidder's experience should be submitted/uploaded. Copy of any supply order prior to the year 2018 / copy of company's registration certificate may be used along with MSME certificate with category of computer selling business for this purpose. Startups will be exempted for experience criteria as per GeM Terms. The bidder with MSME certificate should be classified under any one of the following categories : Repair and maintenance of computer and peripheral equipment; Manufacture of computers and peripheral equipment; computer software and computer hardware; Wholesale of computers.
3. The annual turnover of the bidder should be above Rs.50 lakhs for any one of the past three financial years (2023-24, 2022-23 and 2021-22) OR in past five years. Copy of suitable proof must be uploaded by the bidder. CA audited certified document / Income tax file return is sufficient for this purpose. MSME will be exempted for turn over criteria as per GeM Terms.
4. The bidder must have successfully executed at least 03 supply orders of desktops/workstations/server

s with single order value not less than Rs.15 lakhs. during the past 3 years. The copies of details of such contracts or purchase orders should be furnished / uploaded.

5. The bidder should have a functional office in Tamil Nadu / Puduchery to provide timely support along with OEM of the State during the ONSITE warranty period. Suitable proof (registration / incorporation / certification) containing the local address of the bidder should be furnished. In addition, bidder should provide the manpower details / support contact details, complete address and contact numbers of the local office in their letterhead.
6. An undertaking (self-certificate) should be uploaded stating that the bidder has not been blacklisted by any Central/State Government institutions and there has been no pending litigation with any Government department on account of execution of similar service. The bids from any suspended/disqualified bidder by GeM at the time of bid process will not be considered.
7. The bidder shall furnish scanned copies of MSME, GST registration, PAN/TIN of the firm .
8. The bidder shall furnish their terms and conditions such as delivery period, tax details, service matrix, etc.
9. Purchase preference will be given to MSME/local suppliers under Make In India (MII) in accordance with DPIIT Order dated 04.06.2020. A self certificate stating the status of the local content supplier (Class1 or Class2) as defined in DPIIT order No.P-45021/2/2017-PP (BE-II) dated 4th June, 2020 shall be furnished in the given format.
10. Bidder should furnish the address details of the manufacturing unit of the OEM, where the quoted item is packed.
11. All the self certificates asked in this tender should be provided in bidder's letterhead.
12. Bidders are requested to state the compliance of each specification whether the quoted item is complying with the technical specification as per technical compliance sheet. Technical bids with any non-compliance / false information / not giving any supportive document/brochures not containing the required details/not provided technical compliance sheet as per format will be disqualified at the technical evaluation stage. The technically qualified bids only be considered for further evaluation for the selection of successful bidder based on the total lowest price basis.
13. Bidders are requested to consider only the Terms and Conditions (T&C) of this tender document (this one) for any similar terms and conditions provided in the GeM's terms and conditions. The other standard conditions from GeM portal is also part of the tender.
 14. There is no need of uploading the signed tender document and instead they can use the tender acceptance letter (format given).
 15. The product brochures (system, Monitor, Graphics, KBD and Mouse) of all components are required for technical evaluation and it shall be available in the OEM website. The brochure should contain all the technical specs asked in the tender. If the technical information is not available, the bidders may be asked for a technical demonstration of the quoted item on bidder's own expenses, before the technical evaluation committee / indentor of NCCR. Further, the OEM web address details of the brochures should be provided.
 16. Exemption on qualification criteria will be provided as per the latest Government orders upon verification of suitable valid supportive documents submitted by the bidder.
 17. The bid security declaration form should be furnished in the prescribed format as per Annexure.
18. No request for extension of due date will be considered under any circumstances. The successful bidder should make **5% of total order value as a Security Deposit for warranty period liabilities.**
19. No sub-contracting is acceptable with regard to delivery, installation, warranty maintenance and after sales service.

20. The Director, NCCR reserves the right to accept the offer in full or in parts or reject summarily or partly
21. **Delivery Schedule :** The bidders may please note that the delivery of the system should be completed within 4-6 weeks time from the date of supply order by the successful bidder. A penalty of 3% of total order (without tax) value will be imposed, if there is any delay in delivery (OR) breach of self certification provided by the bidder.
22. **Penalty for delayed Supply, service and LD clause :** As time is the essence of the contract, delivery period mentioned in the Purchase Order / Tender doc should be strictly adhered to. Otherwise **NCCR will forfeit 3% of total order value (without tax) and on applicability of LD clause. In addition, if the supplier fails to supply, install as per specifications mentioned in the order within the next 7 days from the actual due date of supply, the supplier is liable to pay additional liquidated damages of 1% of order value (without tax) per every week of delay** subject to a maximum of 10% beyond the due date. Such penalty amount will be deducted from the amount due or which may become due to the supplier. NCCR reserves the right to cancel the order in case the delay is more than 10 weeks. Penalties, if any, may also be deducted from the Security Deposit during the warranty period.
23. **Jurisdiction :** The disputes, legal matters, court matters, if any, shall be subject to Chennai Jurisdiction only
24. **Force Majeure :** NCCR may consider relaxing the penalty and delivery requirements/schedule, as specified in this document, if and to the extent that the delay, in performance or other failure to perform its obligations under the Contract, is the result of a Force Majeure. Force Majeure is defined as an event of effect that cannot reasonably be anticipated such as acts of God (like earthquakes, floods, storms etc.) acts of states the direct and indirect consequences of wars (declared or undeclared) hostilities, national emergencies, civil commotion and strikes/lockdown at successful Bidder's premises.
25. **Arbitration :** All disputes of any kind arising out of supply, commissioning, acceptance, warranty maintenance etc. shall be referred by either party (NCCR, Chennai or the bidder) after issuance of 30 days' notice in writing to the other party clearly mentioning the nature of dispute to a single arbitrator acceptable to both the parties. The venue for arbitration shall be NCCR, Chennai India The jurisdiction of the courts shall be Chennai, Tamil Nadu, India.

14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
